Arrests

Brandishing of a Firearm – On January 13, officers arrested a driver in connection to a road rage incident that was reported to have occurred in the area of Centreville Rd & Sharlee Ln in Manassas (20111) on January 8 at approximately 12:35PM. The investigation revealed the victim, a 35-year-old man, was driving in the above area when he encountered the driver of another vehicle, later identified as the accused. At one point during the encounter, the accused reportedly brandished a firearm before the parties separated. No shots were fired, and no injuries were reported. On January 13, following the investigation, the accused, identified as Jamar Elijah **FULLWOOD**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On January 12 at 10:22AM, officers responded to the Barnes & Noble located at 15000 Potomac Town Pl in Woodbridge (22191) to investigate a shoplifting. Officers arrived and encountered the suspect, later identified as the accused, exiting the store with unpaid merchandise. During the interaction, the accused became combative and resisted being detained. At one point, the accused was able to break away from officers and flee on foot. Additional officers arrived and located the accused in a nearby parking garage where he was detained. No injuries were reported. The accused was also determined to have shoplifted from the same location three other times between December 2025 and January 2026. Following the investigation, the accused, identified as Severn William Alan **JACKSON**, was arrested.

Assault & Battery on a Corrections Officer – On January 13 at 10:06PM, officers responded to the Prince William-Manassas Adult Detention Center located at 9320 Lee Ave in Manassas (20110) to investigate an assault on staff. The investigation revealed an inmate of the facility, identified as the accused, became combative with officers, repeatedly striking one officer and attempted to strike another. The accused was eventually detained. Minor injuries were reported by one of the officers involved. Following the investigation, officers obtained charges for the accused, identified as Christopher Lee **RICE**.
