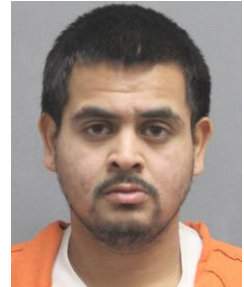
Reckless Handling of a Firearm *ARREST – On January 14, 2026, a suspect, identified as Willy Samuel **JIMENES**, who was determined to be involved in the shots fired call that was reported to have occurred in the area of Botsford Rd and Forrester Ln in Manassas (20109) on December 21, 2025, was arrested. The accused was taken into custody by the U.S. Marshals Service in Sterling.

Arrested on January 14, 2026:

Willy Samuel **JIMENES**, 24, of Manassas

Charged with ***shooting from a vehicle, shooting at an occupied vehicle, reckless handling of a firearm, possession of a firearm by a convicted felon***, and ***destruction of property***

Reckless Handling of a Firearm [Previously Released] – On December 21 at 6:44PM, officers responded to the area of Botsford Rd and Forrester Ln in Manassas (20109) to investigate a shots fired call. The investigation revealed the victims, a 20-year-old man and a 25-year-old man, were sitting in a vehicle in the above area when another vehicle pulled up to theirs where an occupant inside began firing towards them. All parties dispersed prior to officers arriving on the scene. The two victims contacted police later in the evening to report the incident. The victim's vehicle and a home in the area were damaged by gunfire. Shell casings were also found on the roadway. No injuries or other property damage were reported. **This incident does not appear to be random.**

Malicious Wounding | Armed Robbery *ARREST – On January 8, 2026, the suspect, identified as William **TAPSCOTT**, who was sought in connection to an assault that was reported to have occurred in the 10000 block of Brandon Way in Manassas (20109) on December 31, 2022, was arrested.

Arrested on January 8, 2026:

William **TAPSCOTT**, 36, of Woodbridge

Charged with ***malicious wounding, assault by mob, robbery, use of a firearm in commission of a felony***, and ***brandishing***

Malicious Wounding | Armed Robbery [Previously Released] – On December 31, 2022 at 10:49AM, officers responded to investigate an assault that was reported to have occurred in the 10000 block of Brandon Way in Manassas (20109) earlier that morning. The investigation revealed at approximately 2:00AM, the victim, a 32-year-old man, was parked in the parking lot of the above area when a black Cadillac Escalade stopped behind his vehicle. Three men, two of whom were acquaintances, then got out of the Escalade and approached the victim. One of the suspects brandished a firearm and demanded the victim's property. The suspect then physically struck the victim with the firearm before the victim was pulled out of the vehicle and kicked by one of the other suspects. After the assault, the suspects returned to the Escalade and fled the area. The victim reported minor injuries sustained during the encounter. During the investigation, officers identified one of the suspects as William **TAPSCOTT** and obtained warrants for his arrest. Attempts to locate the accused have been unsuccessful. The investigation continues as officers attempt to locate the **TAPSCOTT** suspect and identify the other suspects.
