Incidents

Reckless Handling of a Firearm – On January 17 at 7:19PM, officers responded to the 15000 block of Alabama Ave in Woodbridge (22191) to investigate a destruction of property. The investigation revealed an unoccupied vehicle parked in the above area had been struck by gunfire sometime overnight. No injuries or other property damage were reported. Officers were reportedly in the same area around 12:30AM investigating an assault between known parties. While investigating the incident, officers also heard gunshots in the area. Officers checked the area at that time, no suspect(s) was located.

Commercial Burglary – On January 18 at 11:51AM, officers responded to El Paso located at 3031 Golansky Blvd in Woodbridge (22192) to investigate a burglary. The investigation revealed two men entered the business around 4:40AM, through the roof. Once inside the business, the men took several bottles of alcohol and damaged a cash register before leaving the area on foot. The suspects were two men, one wearing a dark-colored jacket, gray pants, ski mask, and glasses and the other wore a dark-colored jacket, blue pants, ski mask, and a gray beanie cap.

Commercial Burglary – On January 17 at 2:31AM, officers responded to the Sunoco located at 14501 Gideon Dr in Woodbridge (22192) to investigate an alarm activation. The investigation revealed entry had been made into the business through the front glass door which had been shattered. Once inside the business, the suspect took lottery tickets before leaving the area on foot. A police K-9 searched the area for the suspect who was not located. The suspect was described as a white male wearing a dark-colored puffer coat, grey pants, and dark-colored shoes.

Attempted Residential Burglary – On January 18 at 12:26AM, officers responded to a residence located in the 3000 block of Choctaw Ridge Ct in Woodbridge (22192) to investigate an attempted burglary. The investigation revealed four men approached the home and kicked in the front door before running off. No entry was made into the home, and no property was reported missing. The suspects were believed to be in their late teens; all were wearing dark-colored clothing.

Arrests

Malicious Wounding | Abduction – On January 16 at 1:13PM, officers attempted to stop a vehicle in the 14000 block of Spriggs Rd in Woodbridge (22193) regarding a domestic incident. The driver of the vehicle, later identified as the accused, disregarded the officer's emergency equipment and proceeded to Dumfries Rd and eventually onto I-95 where the vehicle was pursued by Virginia State Police (VSP) until terminated as the vehicle continued into Maryland. Later that afternoon, the suspect vehicle was observed in the area of Delaney Rd and Eastlawn Ave where officers again attempted to stop the vehicle. The accused disregarded the officer's emergency equipment a second time and continued onto Dale Blvd and then I-95 where VSP was able to immobilize the vehicle. The accused then fled on foot before being apprehended by pursuing officers. Multiple law enforcement vehicles and two motorist vehicles on I-95 were damaged during the incident. Officers and a VSP trooper reported minor injuries. The victim from the domestic incident, a 21-year-old woman, was located inside the vehicle and was treated at an area hospital for non-life threatening injuries sustained from repeated assaults by the accused. Following the investigation, the accused, identified as Carlos Alberto **GOMEZ-LOZANO**, was arrested.

Brandishing a Firearm – On January 19 at 12:24AM, officers responded to Bar Louie located at 15001 Potomac Town Pl in Woodbridge (22191) to investigate a fight. The investigation revealed a patron of the restaurant, later identified as the accused, was involved in a verbal altercation with an employee when another customer intervened. The two parties then exited the establishment to the parking lot where the accused brandished a firearm. No shots were fired. The accused was disarmed by the other party, and the firearm was secured until officers arrived on scene. No shots were fired and no injuries were reported. Following the investigation, the accused, identified as Devante Antonio **MURRAY**, was arrested.

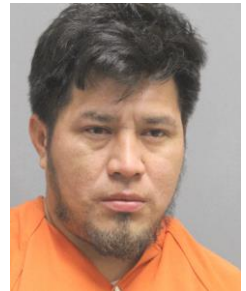

Assault & Battery on a Law Enforcement Officer [LEO] – On January 19 at 12:04AM, officers responded to a residence located in the 13600 block of Forest Glen Rd in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed one of the parties involved, identified as the accused, was wanted on charges related to a separate domestic encounter. While attempting to take the accused into custody, he became combative, leading to a struggle. During the altercation, the accused kicked multiple officers and grabbed one of them before being detained. No injuries were reported. Following the investigation, the accused, identified as Jose Gerson **VASQUEZ**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] | Indecent Exposure – On January 15 at 11:25AM, officers responded to the GNC located at 7539 Linton Hall Rd in Gainesville (20155) to investigate a disorderly. The investigation revealed the accused entered the business and began approaching other customers in an aggressive way. At one point, the accused left the business and exposed herself to the customers through the front window. Officers arrived and attempted to detain the accused who resisted, leading to a struggle. During the altercation, the accused grabbed an officer's leg before Good Samaritans intervened to assist. The accused was eventually detained. An officer reported minor injuries. Following the investigation, the accused, identified as Danielle Maria **BLASER DIAZ**, was arrested.
