### Incidents

**Strong-Arm Robbery** – On January 23 at 4:35PM, officers responded to Target located at 9900 Sowder Village Sq in Manassas (20109) to investigate a robbery. The investigation revealed a loss prevention employee attempted to stop an unknown man for shoplifting when the man became physically combative and assaulted an employee before exiting the store and leaving the area on foot. No injuries were reported and no suspect description was provided.

**Reckless Handling of a Firearm** – On January 23 at 10:51AM, officers responded to the 8000 block of Stillbrooke Rd in Manassas (20112) to investigate a destruction of property. The investigation revealed the victims, a 16-year-old male juvenile and a 42-year-old man, was driving in the above area when the rear window of a vehicle suddenly shattered. A hole was located in the window. No casings or other evidence of a shooting were located and no injuries or other property damage were reported.

### Arrests

**Malicious Wounding | Residential Burglary** – On January 24 at 10:07PM, officers responded to the Woodbridge Forest Apartments located in the 1500 block of Monroe Dr in Woodbridge (22191) to investigate an assault. The investigation revealed the victims, a 60-year-old man and a 68-year-old woman, were walking to an apartment when they passed an unknown man, later identified as the accused, who was sitting in the hallway. As the victim's were entering the apartment, the accused pushed past the female victim and began assaulting the male victim. During the assault, the male victim sustained a laceration to his ear. Officers arrived and detained the accused without further incident. The male victim was treated at an area hospital for non-life threatening injuries. The female victim was not injured. Following the investigation, the accused, identified as Erick Ernesto **LOZANO**, was arrested.

**Shooting a Weapon from a Vehicle** – On January 26 at 4:33AM, officers in the 14200 block of Richmond Hwy in Woodbridge (22192) observed a vehicle drive by followed by multiple gunshots being heard. Officers conducted a traffic stop on the vehicle and detained the occupants, including the driver, identified as the accused. The investigation revealed the accused had fired several rounds from the vehicle. No injuries or property damage were reported. The accused had discarded the weapon out of the window prior to officers stopping the vehicle. The firearm was recovered from the roadway and multiple casings were located inside the vehicle. Following the investigation, the accused, identified as Mario Alexadner **TORRES VALERIANO**, was arrested.
