Updates

Armed Robbery | Reckless Handling of a Firearm *ARREST – On February 5, 2026, detectives obtained charges for two suspects sought in connection to the robbery that was reported to have occurred in the 18000 block of Dumfries Shopping Plz in Dumfries (22026) on December 20, 2025. Following the investigation, detectives obtained detention orders against the two accused, identified as a **17-year-old male juvenile** and a **16-year-old male juvenile**, who both remain in custody.

Armed Robbery | Reckless Handling of a Firearm [Previously Released] – On December 20 at 4:26PM, officers responded to Dumfries Shopping Center located in the 18000 block of Dumfries Shopping Plz in Dumfries (22026) to investigate a robbery. The investigation revealed the victim, a 21-year-old man, arranged to sell clothing items through the “Offer Up” app to an unknown party at the above shopping center. Once in the area, the victim met with two men accompanied by two women. During the encounter, one of the men reached into the victim’s vehicle and grabbed the clothing items from the victim. The victim drove off, at which point one of the suspects fired a handgun towards the victim’s vehicle which penetrated through the back glass and struck the vehicle’s front console. No injuries or other property damage were reported. The two suspects were described as black males, both in their late teens to early 20s and approximately 6’0”.

Incidents

Strong-Arm Robbery – On February 4 at 7:18PM, officers responded to the Shell gas station located at 15550 Neabsco Mills Rd in Woodbridge (22191) to investigate a robbery. The investigation revealed an unknown man approached the service counter where he then handed the employee money. As the cash register drawer opened, the man grabbed the employee's hands and took money out of the register. The man then pushed the employee and left the area. No injuries were reported. The suspect was described as a Hispanic male, wearing a dark gray hoodie, ski mask, dark-colored Croc shoes, and white socks.

Brandishing of a Firearm – On February 4 at 11:49PM, officers responded to the Motel 6 located at 17133 Dumfries Rd in Dumfries (22025) to investigate brandishing. The investigation revealed the victim, a 51-year-old man, was attempting to repossess a vehicle when an unknown man approached the victim and brandished a firearm. The man then left the area in a silver sedan, possible a Hyundai. No shots were fired and no injuries were reported. The suspect was described as a black male wearing Adidas-brand clothing.

Arrests

Assault & Battery on a Law Enforcement Officer [LEO] – On February 3 at 5:25PM, officers responded to the area of Delaney Rd and Kurtz Rd in Woodbridge (22193) to investigate a crash. The investigation revealed a vehicle had been reportedly driving recklessly through a construction zone. At one point the driver, later identified as the accused, exited the vehicle and exposed herself before getting back into the vehicle and striking a construction worker's vehicle. The accused then attempted to leave the scene before being stopped. Two young children between 6-8 years of age were located inside the vehicle with the accused who was determined to be intoxicated. The children were not injured. Following the investigation, officers arrested the accused, identified as Gisselly **GONZALEZ**. While in custody, the accused damaged an officer's computer and assaulted a Manassas City police officer who was at the Prince William-Manassas Adult Detention Center on an unrelated matter. Minor injuries were reported by the officer and additional charges were obtained.

Assault & Battery on a Law Enforcement Officer [LEO] – On February 4 at 8:25PM, officers responded to the 10900 block of Coverstone Dr in Manassas (20109) to conduct a warrant service on the accused. Once at the home, officers made contact with the accused who opened the door and assaulted an officer before fleeing further inside the residence. Officers caught up to the accused where a struggle then ensued. The accused briefly locked himself in a room before surrendering to officers without further incident and subsequently detained. Minor injuries were reported by the officer. Following the investigation, the accused, identified as Santos Melaneo **RODAS-PINEDA**, was arrested.
