Incidents

Armed Robbery – On February 8 at 5:33PM, officers responded to investigate a robbery that was reported to have occurred at the Round One inside Potomac Mills located at 2700 Potomac Mills Cir in Woodbridge (22192) on February 7 at approximately 5:10PM. The investigation revealed the victim, a 14-year-old male juvenile, was with other friends at the location when he was approached by a group of juveniles. During the encounter, the group held the victim down and implied they were armed. The suspects took the victim's shoes and left the area. No injuries were reported, and no firearm was seen.

Suspect Descriptions:

Black male wearing a black sweatshirt, camouflage patterned pants, black shoes, and a camouflage-patterned ski mask,

Black male wearing a white shirt, black jacket, blue jeans, blue face mask and grey beanie hat

Hispanic male wearing all black clothing and a grey beanie hat

Black male wearing a blue jacket, blue jeans and blue mask

An unknown race male wearing all black with a black beanie hat

Strong-Armed Robbery – On February 7 at 6:05PM, officers responded to the 2700 block of Caton Hill Rd in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 26-year-old man, was walking in the above area when he was approached by a dark-colored vehicle occupied by three unknown men. During the encounter, the victim was pulled into vehicle and driven to a nearby service road where he was assaulted. The suspects took an undisclosed amount of money from the victim before leaving the area. Minor injuries were reported. The suspects were described as two black males and a Hispanic male, all wearing dark-colored clothing.

Reckless Handling of a Firearm – On February 7 at 1:21AM, officers responded to the 3100 block of Antrim Cir in Dumfries (22026) to investigate a shots fired call. The investigation revealed multiple gunshots were heard in the above area. No injuries or property damage were reported. Several shell casings were located in the woods behind Antrim Cir. A witness reported seeing an unknown man leaving the area. The man was described as a black male wearing a black hoodie and black pants.

Reckless Handling of a Firearm – On February 8 at 9:10PM, officers responded to the area of Chesapeake Dr and Richmond Hwy in Dumfries (22026) to investigate a shots fired call. The investigation revealed the victims, a 20-year-old male and a 23-year-old female were driving on Chesapeake Dr when their vehicle was struck by gunfire. No injuries or other property damage were reported. Several shell casings were located in the roadway on Chesapeake Dr. No suspect information was provided.

Arrests

Shooting into an Occupied Vehicle | Reckless Handling of a Firearm – On February 6 at 8:00PM, officers responded to the 10400 block of Sudley Manor Dr in Manassas (20109) to investigate a shooting. The investigation revealed a verbal argument occurred between a group of individuals and the occupants of a vehicle in the parking lot. During the encounter, one of the parties, later identified as the accused, brandished a firearm and shot at the vehicle, striking it multiple times. A second vehicle, occupied by three uninvolved parties, was also struck by causing minor injuries from shattered glass. The occupants were treated at an area hospital. No other injuries were reported. Following the investigation, the accused, identified as a Demetrius John **EATON**, was arrested.

Brandishing of a Firearm – On February 6 at 3:50PM, officers responded to the 15000 block of Benita Fitzgerald Dr in Woodbridge (22193) to investigate a road rage. The investigation revealed the victim, a 48-year-old male, was involved in a verbal altercation with the driver of another vehicle, later identified as the accused. During the encounter, the accused brandished a firearm at the victim before the parties separated. No shots were fired and no injuries were reported. Following the investigation the accused, identified as Borpit **SEEKAJOHN** was arrested.
