### Incidents

**Strong-Armed Robbery** – On February 12 at 5:05AM, officers responded to the Wawa located at 13355 Minnieville Rd in Woodbridge (22192) to investigate a robbery. The investigation revealed an unknown man walked behind the service counter and grabbed multiple cartons of cigarettes. As the man was leaving the store, two employees attempted to stop him. During the encounter, the suspect pushed the employees and left the area in a vehicle. No injuries were reported. The suspect was described as a black male, wearing a grey hoodie, black pants, grey shoes and a black ski mask.

**Vandalism on School Grounds** – On February 11 at 1:50PM, the School Resource Officer (SRO) assigned to Forest Park High School located at 15721 Forest Park Dr in Woodbridge (22193) was notified of vandalism in one of the restrooms. The investigation revealed a swastika and other lettering had been drawn on the door of one of the bathroom stalls. No additional markings were reported, and school personnel removed the markings from the door.

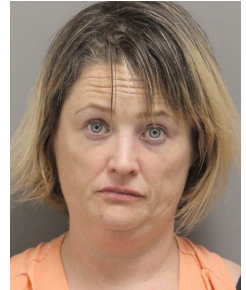

## Arrests

**Malicious Wounding** – On February 12 at 9:12AM, officers responded to Sentara Northern Virginia Medical Center located at 2300 Opitz Blvd in Woodbridge (22191) to investigate a disorderly. The investigation revealed the accused was acting erratically and locked herself in a bathroom. At one point, a security guard attempted to open the bathroom door. As the door opened, the accused stabbed the security guard in the hand with a sharp instrument. Minor injuries were reported. The accused was taken into custody by officers for a medical evaluation. While in custody, the accused became agitated and threw water at one of the officers. Following the investigation the accused, identified as Jessica Clare **SMALLFIELD**, was arrested.
