### Incidents

**Shooting Investigation-** On February 13, officers responded to investigate a shooting that was reported to have occurred in the area of Delaney Rd and Minnieville Rd in Woodbridge (22193) at approximately 5:50PM. The investigation revealed the victim, a 17-year-old male juvenile, was in a wooded area near the intersection when an unknown man approached him, brandished a firearm and demanded his belongings. The suspect then shot the victim in the foot and left the area. The victim was treated at an area hospital for non-life-threatening injuries. The victim was not forthcoming with information as to what led up to the shooting. The suspect was described as a white male wearing blue pants. **This incident does not appear to be random.**

**Felony Hit and Run-** On February 15 at 8:55AM, officers responded to the 7-Eleven located at 2621 Prince William Pkwy in Woodbridge (22192) to investigate a hit and run. The investigation revealed the victim, a 59-year-old man, was in the parking lot when he was struck by a white sedan, driven by an unknown man. After striking the victim, the suspect circled back into the parking lot. When the victim attempted to approach the suspect, the suspect struck the victim with the sedan a second time, before leaving the area in the vehicle. The victim was treated at an area hospital for non-life-threatening injuries. The suspect was described as a black male wearing dark clothing.

**Reckless Handling of a Firearm-** On February 15 at 11:42AM, officers responded to a residence located in the 3000 block on Lacrosse Ct in Woodbridge (22193) to investigate a shots fired call. The investigation revealed several gunshots were fired, which struck the home. No shell casings or other evidence of a shooting were located, and no injuries or other property damage were reported. No suspect information could be provided.

**Reckless Handling of a Firearm-** On February 14 at 3:58PM, officers responded to the 3000 block of Lacrosse Ct in Woodbridge (22193) to investigate as shots fired call. The investigation revealed multiple gunshots were heard in the above area. No injuries or property damage were reported. The location of where the gunshots were fired could not be determined. No suspect information could be provided.

## Arrests

**Possession of a Firearm on School Property-** On February 14 at 1:44PM, officers responded to the Manassas Mall located at 8300 Sudley Rd in Manassas (20109) to investigate a report of brandishing. The investigation revealed two unknown men were seen arguing in the mall when one of the men, identified as the accused, brandished a firearm before leaving the area. Officers checked the surrounding area and located the accused, who fled on foot from officers. Officers observed the accused run onto the grounds of Westgate Elementary School where he was quickly detained. Following the investigation, the accused, identified as Tasheem Rashad **DOUGLAS**, was arrested.
