Incidents

Armed Robbery- On February 26 at 6:38AM, officers responded to a residence located in the 11400 block of Mercury Dr in Manassas (20112) to investigate a robbery. The investigation revealed the victim, identified as a 44-year-old man, was attempting to retrieve an item from inside his vehicle when he was approached by two unknown men. During the encounter, one of the suspects struck the victim with an aluminum bat while the other suspect brandished a firearm at the victim. The suspects demanded the victim's belongings before leaving the area. Minor injuries were reported by the victim. A police K-9 searched the area for the suspects who were not located.

Suspect descriptions:

Hispanic male, 5' 5", 160lbs, wearing a gray hoodie, gray pants, and dark face covering

Hispanic male, 5' 5", 160lbs, wearing a black hoodie, black face covering, with dark pants

Reckless Handling of a Firearm- On February 26 at 10:30PM, officers responded to a residence located in the 12600 block of Dulcinea Pl in Woodbridge (22191) to investigate a shots fired call. The investigation revealed several gunshots were fired, which struck the home and two vehicles that were parked nearby. Multiple shell casings were recovered in the area. No injuries or other property damage were reported. A dark sedan was reportedly seen leaving the area after the shots were fired. No further suspect information could be provided.

Reckless Handling of a Firearm- On February 26 at 6:02PM, officers responded to a residence located in the 12500 block of Aden Rd in Nokesville (20181) to investigate a shots fired call. The investigation revealed a neighbor, later identified as the accused, was shooting at wildlife on his property when one of the rounds that was fired entered the neighboring residence. No injuries or other damage to property was reported. Following the investigation, the accused, identified as Matthew Patrick **SCHROER**, was arrested.

Brandishing- On February 26 at 4:37PM, officers responded to the Costa Real Restaurant, located at 8423 Sudley Rd in Manassas (20109) for a disorderly with weapons call. The investigation revealed the victim, a 19-year-old man, and two acquaintances were involved in a verbal altercation with an unknown man, later identified as the accused. During the argument, the accused brandished a firearm at the victim before the parties separated. Following the investigation the accused, identified as Jason Napoleo **SORIANO-MORALES**, was arrested.
