Public Comment for Proposed Changes to the Prince William County Public Housing Agency (PHA) Administrative Plan

The Prince William County Office of Housing and Community Development (OHCD) is proposing changes to the PHA Administrative Plan. The DRAFT Plan was developed in partnership with Nan McKay, where updates were made to ensure compliance with current HUD regulations. The Draft Plan is in compliance with the Code of Federal Regulations 24 CFR Part 982, 24 CFR Part 983, Fair Housing and Housing Opportunity Through Modernization Act (HOTMA) 24 CFR 993.260.
