

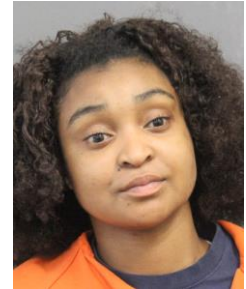

Updates

Fatal Crash Investigation *ARREST - On April 21, crash investigators arrested the driver involved in the fatal collision that killed two individuals in the area of Cardinal Dr and Whips Run Dr in Woodbridge (22193) on March 8. The investigation revealed the driver of a 2015 Hyundai Genesis, identified as the accused, was under the influence and traveling in excess of the posted speed limit when her vehicle crossed over the median into the opposite lanes of travel and collided head on with a 2024 Hyundai Sante Fe, killing both the driver of the vehicle and a front seat passenger. The driver of a third vehicle involved in the collision was uninjured. Following the investigation, crash investigators obtained arrest warrants for the accused who was taken into custody on April 21.



Arrested on April 21:

Jasmine Aria **THOMAS**, 27, of Woodbridge [Driver of the 2015 Hyundai Genesis]

Charged with two counts of **aggravated involuntary manslaughter**, one count of **expired registration**, and one count of **operating an uninsured vehicle**

The deceased driver and passenger of the 2024 Hyundai Santa Fe were identified a **40-year-old woman** and a **42-year-old man**, both of Woodbridge

**Continuation of the investigative update on the previous page.*

Fatal Crash Investigation [Previously Released] – On March 8 at 6:45PM, officers responded to the intersection of Cardinal Dr and Whips Run Dr in Woodbridge (22193) to investigate a multi-vehicle crash. The investigation revealed the driver of a 2015 Hyundai Genesis was traveling the wrong way in the eastbound lanes of Cardinal Dr, approaching Whips Run Dr when it struck a 2024 Hyundai Santa Fe that was traveling eastbound, in a head-on collision. The force of the impact caused the Hyundai Santa Fe to collide with a 2025 GMC Hummer that was also traveling eastbound on Cardinal Dr. Debris from the crash struck an unoccupied 2024 Honda Accord parked in a nearby driveway on Whips Run Dr. The driver of the Hyundai Genesis was transported to an area hospital with life-threatening injuries. The driver and a passenger in the Hyundai Santa Fe were also transported to an area hospital, where they were both pronounced deceased. No injuries were reported by the driver of the GMC Hummer. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**
