Incidents

Strong-Armed Robbery- On May 16 at 8:30PM, officers responded to Potomac Mills, located at 2700 Potomac Mills Cir in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 14-year-old male juvenile, was sitting in the common area with three acquaintances when he was approached by two unknown male juveniles. During the encounter, the suspects pushed the victim to the ground and took his Balenciaga shoes, before leaving the area on foot. No injuries were reported.

Suspect description:

White male juvenile, wearing an under-armor t-shirt, black puffer jacket, black backpack and a dark colored ski mask on his head

White male juvenile, with dark curly hair, wearing glasses, a black puffer jacket, blue jeans and a dark colored ski mask on his head

Strong-Armed Robbery- On May 17 at 3:26AM, officers responded to the area of Richmond Hwy and Vantage Dr in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 27-year-old man, was walking on Richmond Hwy when he was approached by two unknown men that were standing in a wooded area near Vantage Dr. During the encounter, the men assaulted the victim and took his wallet before leaving the area on foot. Minor injuries were reported by the victim. The suspects were described as two black males wearing black hoodies.

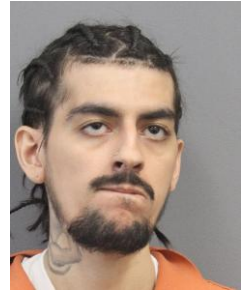

Brandishing- On May 16 at 2:40PM, officers responded to the 4700 block of Minnieville Rd in Woodbridge (22193) to investigate brandishing. The investigation revealed a man, later identified as the accused was driving his vehicle on Minnieville Rd when he became involved in a verbal argument with three unknown men that were attempting to cross the street. During the encounter, the accused exited his vehicle, grabbed his firearm and pointed it in the air. No injuries were reported and no shots for fired. Following the investigation, the accused, identified as Edrees **ETEBAR**, was arrested.
