Malicious Wounding- On June 3, officers responded to investigate an assault that was reported to have occurred at Jiffy Lube Live, located at 7800 Cellar Door Dr in Bristow (20136) at approximately 9:10PM that evening. The investigation revealed the victim, an 18-year-old man, was approached by two unknown men. During the encounter the suspects became aggressive and assaulted the victim, before leaving the area on foot. The victim sustained injuries and was treated at an area hospital.

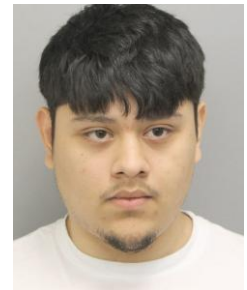
Suspect description:

Malicious Wounding- On June 1, officers responded to investigate an assault that was reported to have occurred in the 14200 block of Radford Ct in Woodbridge (22191) at approximately 4:22PM that afternoon. The investigation revealed the victim, a 14-year-old male juvenile, was with an acquaintance and rang the doorbell to a residence in the area and walked away. During the encounter, an occupant of the residence, later identified as the accused, confronted the victim and assaulted him, before leaving the area in a vehicle. The victim sustained injuries and was treated by medics. Following the investigation, officers obtained charges and the accused, identified as Byron Steve **SANDOVAL POLANCO** was arrested.

Reckless Handling of a Firearm- On May 23 at 8:00PM, officers responded to investigate a self-inflicted shooting that was reported to have occurred in the 11400 block of Whispering Dove Pl in Manassas (22112) between 6:00PM and 8:00PM that evening. The investigation revealed a man, identified as the accused, was seated in his vehicle showing his firearm to an acquaintance when the firearm discharged, striking the accused in the leg. The accused sustained non-life-threatening injuries and was transported to an area hospital for treatment. While processing the vehicle, officers recovered items consistent with the sale of marijuana. Following the investigation, officers obtained charges and the accused, identified as Royale Cameron **LOIBMAN**, was arrested.

Possession of a Weapon on School Grounds – On May 26 at 1:25PM, the School Resource Officer (SRO) at Potomac Shores Middle School located at 17851 Woods View Dr in Dumfries (22026) was notified of a student who was found in possession of a knife. The investigation revealed security staff had recovered the knife and notified the SRO. The student did not threaten other students or staff or display the knife. Following the investigation, the student, identified as a **14-year-old male juvenile**, was charged.
