**Malicious Wounding by Mob \*UPDATE-** On June 23 officers arrested two suspects in connection with the malicious wounding that was reported to have occurred at Jiffy Lube Live, located at 7800 Cellar Door Dr in Bristow (20136) on June 3. Following the investigation the two accused, identified as Shaun Jeremy **AUBREY** and Cayden Daniel **KING**, were arrested by Fauquier County Sheriff's Office.

**Malicious Wounding [Previously Released]-** On June 3, officers responded to investigate an assault that was reported to have occurred at Jiffy Lube Live, located at 7800 Cellar Door Dr in Bristow (20136) at approximately 9:10PM that evening. The investigation revealed the victim, an 18-year-old man, was approached by two unknown men. During the encounter the suspects became aggressive and assaulted the victim, before leaving the area on foot. The victim sustained injuries and was treated at an area hospital.

## Arrests

**Shooting into an Occupied Dwelling | Armed Robbery-** On June 22, detectives concluded an investigation into a home invasion that was reported to have occurred at a residence located in the 1700 block of Pine Shadows Way in Woodbridge (22192) on April 15. The investigation revealed the victim, a 30-year-old man, was robbed by three acquaintances who forced their way into his home, displayed firearms and took multiple items. During the encounter, one of the men, identified as the accused, fired a gunshot towards the residence, striking a wall. No injuries or other property damage were reported. Following the investigation detectives obtained arrest warrants for the accused, identified as Nascair Elijah **NORALEZ**, who was arrested on June 22. Two other adult men were also previously arrested in connection to the home invasion.

Nascair Elijah **NORALEZ**, 19, of Woodbridge

Charged with *shooting into an occupied dwelling, attempted malicious wounding, robbery, burglary, abduction, conspiracy to commit robbery*, and *use of a firearm in commission of a felony*

Court date: **Pending** | Status: **Held WITHOUT Bond**

**Assault and Battery on a Law Enforcement Officer [LEO]-** On June 23 at 9:54AM, officers were in the area of Notre Dame St and Coverstone Dr in Manassas (20109) when they located an individual who needed to be served trespassing paperwork. As officers attempted to stop the individual, identified as the accused, a struggle ensued and he assaulted an officer before fleeing the area on foot. Minor injuries were reported by the officer. The accused was located later that day and again fled from officers, before being taken into custody. During a search of the accused, an illicit substance was located on his person. Following the investigation, the accused, identified as Robert Glen **EDMANSON** Jr, was arrested.

Charged with one count of *assault & battery on a LEO*, 1 count of *possession of a controlled substance* and two counts of *obstruction of justice*
