Malicious Wounding *UPDATE- On July 26, the suspect sought in connection with the malicious wounding that was reported to have occurred at the Sheetz located at 5350 Dale Blvd in Woodbridge (22193) on July 7 was arrested. Following the investigation, officers obtained charges for the accused, identified as a **16-year-old male juvenile**, who was arrested on July 26.

Malicious Wounding [Previously Released]- On July 7, officers responded to the Sheetz located at 5350 Dale Blvd in Woodbridge (22193) to investigate an assault that was reported to have occurred at approximately 2:19PM that afternoon. The investigation revealed an unknown man entered the store and took multiple items of merchandise. While exiting the store, the suspect assaulted a customer, before leaving the area on foot. The victim, a 65-year-old woman, sustained injuries and was transported to an area hospital for treatment. The suspect was described as a light-complexioned male, age 20-30 years old, with dark hair, wearing a black and tan jacket and black backpack.

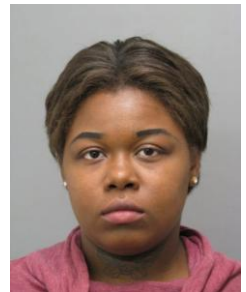

Death Investigation- On July 28 at 12:58PM, officers responded to Andrew Leitch Park, located at 5301 Dale Blvd in Woodbridge (22193) to investigate a report of an unconscious individual. The investigation revealed the individual, identified as a 16-year-old male juvenile, was located along a wooded trail in the above area with an apparent self-inflicted injury. The juvenile was pronounced dead on scene. Preliminarily, there were no signs of foul play concerning the death. More information regarding the investigation will be released if deemed necessary.

Reckless Handling of a Firearm- On July 26, officers responded to El Establo, located at 14440 Richmond Hwy in Woodbridge (22191) to investigate a report of shots fired. The investigation revealed at approximately 1:47AM that morning, the suspect and an acquaintance became involved in an altercation with an unknown man. During the altercation, the man struck the suspect with a cup. The suspect then went to her vehicle, grabbed her firearm from the vehicle and fired a single gunshot. No injuries or property damage were reported. Officers located a shell casing in the parking lot. Following the investigation, officers obtained arrest warrants for the suspect, identified as Avisha Brianna **SMITH**. Attempts to locate **SMITH** were unsuccessful.

Arrests

Malicious Wounding | Armed Robbery- On July 26, officers responded to investigate a robbery that was reported to have occurred at King Elementary School, located at 13224 Nickleson Dr in Woodbridge (22193) at approximately 10:08AM that morning. The investigation revealed the victim, a 17-year-old male juvenile, was on the basketball courts when he was approached by three acquaintances. During the encounter, two of the acquaintances, identified as the two accused, assaulted and robbed the victim. During the assault, one of the accused displayed a knife, cutting the victim's hand and hair, before leaving the area on foot. The victim sustained injuries and was treated by medics. Following the investigation the two accused, identified as a **16-year-old male juvenile** and a **17-year-old male juvenile**, were arrested.
