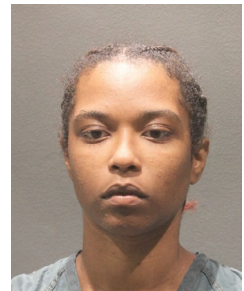
Murder Investigation *ADDITIONAL ARRESTS- Between August 6 and 11, Prince William County police, with assistance from the U.S. Marshals Fugitive Task Force and Arlington County police, arrested four additional suspects in connections to the shooting death of a **16-year-old male juvenile** that occurred in the 16700 block of Blackjack Oak Ln in Woodbridge (22191) on July 5. The investigation revealed the deceased, and two acquaintances, identified as Janaiya Lolita **TALLEY** and a **17-year-old female juvenile**, arranged to confront and rob another man, identified as Damion Jamon **ATWATER**, at the above location. During the encounter, shots were fired which fatally struck the deceased. After the incident, another man who had accompanied the deceased, identified as Darrian King **RUTHERFORD**, left the scene in a vehicle which officers attempted to stop and then pursued in connection to the investigation. At one point, **RUTHERFORD** stopped the vehicle and fled on foot. The investigation further revealed an additional man, identified as Keshawn Maurice **HODGE-RICHARDS**, went to the area of the shooting prior to initial responding officers, and tampered with evidence at the scene before leaving the area. The **ATWATER** suspect was previously arrested in connection with this investigation on July 30. Following the investigation, all parties involved in the incident were identified and arrested.

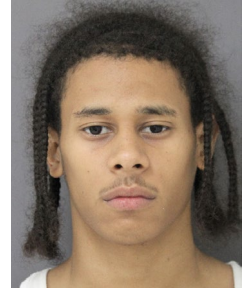

Murder Investigation *ARREST [Previously Released]- Prince William County detectives have charged a man in connection to the shooting death of a 16-year-old male juvenile that occurred in the 16700 block of Blackjack Oak Ln in Woodbridge (22191) on July 5. On July 30 Prince William County detectives, with the assistance of the U.S. Marshals arrested the accused, identified as Damon Jamon **ATWATER** at this home in Woodbridge. The investigation continues.

Homicide Investigation [Previously Released]- On July 5 at 10:12PM, officers responded to the 16700 block of Blackjack Oak Ln in Woodbridge (22191) to investigate a shooting. Arriving officers located the victim, a 16-year-old male juvenile, in a parking lot in the above area with a gunshot wound to the upper body and immediately rendered aid. The victim was transported to an area hospital where he later died from his injuries. A possible involved vehicle was reportedly seen leaving the area following the shooting. Later that evening, officers observed a vehicle matching the description of the suspect vehicle on Cardinal Dr near Emil Ct where a vehicle stop was attempted. The driver refused to stop for officers and a pursuit was initiated. The driver continued to the area of Powell's Creek Blvd and Blue Pool Ln where the driver then stopped the vehicle and fled on foot. The driver was not immediately located. **Preliminarily, this incident does not appear to be random, and detectives are asking anyone with information to contact police.** Additional information will be released when available. The investigation continues.

Incidents

Death Investigation- On August 11 at 8:37PM, officers responded to the 16300 block of Sandy Ridge Ct in Woodridge (22191) to investigate a report of an unconscious individual. The investigation revealed the individual, identified as a 35-year-old man, was located inside his vehicle with an apparent self-inflicted injury. The man was pronounced dead on scene. Preliminarily, there were no signs of foul play concerning the death. More information regarding the investigation will be released if deemed necessary.

Armed Robbery- On August 11, officers responded to investigate a robbery that was reported to have occurred in the 10200 block of Portsmouth Rd in Manassas (20109) between 6:45PM and 7:45PM that evening. The investigation revealed the victim, a 33-year-old man, was walking in the area when he was approached by an unknown man. During the encounter, the suspect struck the victim with a hammer, before taking an undisclosed amount of money from the victim. The victim sustained injuries and was treated by medics. The suspect was described as a black male.
