Project should be for 95 units. If 50 units is the average number of annual projects, a 90% increase is a significant increase without a additional increase in staff.

2. How is the number of assisted persons determined? National Objective says 68 people served and Project Description says 64 persons served. Work for this proposal begins on July1, 2021 and worksheet shows that 26 persons will be disabled and 36 elderly. How is that known and what if they are both? Are they counted twice?

Did not provide a agency salary sheet showing agency salary structure to corroborate staff cost request.
 Lead based Paint: Did not provide a copy of Project Managers EPA Lead Certification and how PMAH will comply with federal lead based paint guidelines when working with properties built prior to 1978, specifically testing and remediation efforts.

6.Project timeline show that items will be ordered in advance of specific projects being identified. How do they know what each project will need and how do they determine if they will need 4 heat pumps or 3 stair climbers and what happens if they need 6 heat pumps and 1 stair climber? Is there a waiting list with these items already identified as needs, and if so this should have been explained.

National Objective detail regarding number to be served is unclear. Application notes, 68 people, 68 Household and 45 units for a total of 113 or 181 (unclear). Project description states 45 persons additional to previous years will be assisted with requested and match funding.

In project description, regarding who specifically will administer this project, only titles are noted, however actual people are not identified. The Activity schedule only details types of repairs, no administration (coordination or scheduling of work, clients, files or reporting) is noted, however every position is listed as completing every task noted, and the Sponsor capacity only identifies two specific people with general credential information.

It is noted that there will not be additional staff, however costs to existing positions are noted, there is no reference as to how these amounts were derived or how they are separate from the work not covered by this project.

50 applicants stated as "in the queue", however it is not identified how this information relates to the current application or if the references applicants are taken into consideration for the FY22 project.

Reviewer Notes: Several requirements were not addressed or vaguely addressed:

-How was the goal of 20 persons to be served derived? No detail or calculation was provided.

-Funds were allocated for kitchen and café equipment and salaries, however nothing was stated regarded the state/completion of the facility for the new equipment. Is it otherwise ready to open for business? Are all permits acquired?

- Regarding who will administer the activity, nothing was stated regarding the status of the new employees, or the qualification criteria, whether they are currently on-staff or will be new employees. Project description only identified titles of positions. For example, the café manager position; there were no specifications regarding responsibilities to the clients (20 to be served) or their capacity for working with "I/DD" individuals or running a café of this type.

-Also no timeline, criteria or process for hiring for new positions was provided. Only the mention that they would start July 1, 2021 was made in the Activity Schedule.

-Future Income noted to cover future expenses was only a general idea, not actual projections, no source of income or commitment references provided.

-There were no cost estimates for operation costs, café income projections, or the source of funds to cover operational costs

- No financial audit provided. Budget provided reflected no activity in-line with "Vocation Training" project, it was very general and did not seem to reflect complete organization operations.

-Only two people were identified within the sponsor capacity description, however several positions are identified as essential positions to the project.

-Board meeting minutes does not mention forgivable nor lack of matching funds

-B.4 Blank, no selection made

-Tax return provided, states organization mission / description is to provide adult day care and miscellaneous services to seniors, however the organization website does not reflect senior services.

Project Description is confusing

- Requesting 'reimbursement' (replenishing funds already spent as opposed to using new funds?)
- The first statement refers to food delivery but the majority of the project description refers to transportation to work and community services
- PWC CDBG Funds would be used for services in other counties
- COVID19 economic recovery is mentioned throughout
- Goals and Objectives increased employment satisfaction? Increased number of people that can continue to live independently at home while receiving services-- How does transportation increase number of people living at home independently?
- Registration process states applicants must be a PWC resident how does a homeless person provide proof of residency? How is food delivered to homeless persons?
- 50% AMI what is the source of AMI figure?
- Transportation planning gives low priority to the most vulnerable/special populations who need community services

• Community Outreach and Marketing describes solicitations of donations; there is no mention of CDBG funds used for this project. Outreach to every employer and business in PWC (not sure it is possible how to reach every employer and every business). Refers to 'tax deductible' contribution by PWC when source of

funding is CDBG, not PWC. Implies PWC benefits because donation is tax-deductible. Other counties should not be included when referring to PWC's CDBG funding

• Number of persons served- unclear as to how these numbers are determined

• Activity site- This is a service related activity, not property related. Is description referring to the site where everyone works (offices, food storage, truck hub etc.)? If so, where is property and is it owned or leased? Audit states there is a property under lease that expires December 2020 but there is no mention of renewal

• Activity schedule starts prior to FY22

Board Authorization and Match – does not state who moved nor who seconded the motion. Also doesn't identify who was there to vote and who was absent.

Only one "Declaration of Economic Interest" form and it was signed by all members. Each member should complete and sign a separate form. Also, the form everyone signed states a spouse or family member has a financial interest but no details nor explanation provided.

Organizational Chart has no names

Cost Estimate is \$890,066 for this activity does not match budget \$350,740. Source or methodology used to calculate estimate not included

Sponsor Capacity lists on-site manager and states this person will manage operations in Birmingham, not PWC . No Articles of Incorporation?

No scores were provided because application is ineligible
