Solid Waste Disposal Decal Program



Prince William County residents may apply for a "Solid Waste Disposal - Residential User" decal that will allow for faster entry when using the County Landfill, Balls Ford Road Compost Facility, rural park-outs, and the Household Hazardous Waste collection sites. Information on how to obtain a decal is on the reverse side. This decal is not available for commercial users.

We encourage regular residential users of the landfill or other solid waste facilities to obtain and display this decal to facilitate entry. However, a Solid Waste Disposal - Residential User decal is not required and residency can still be established by showing your driver's license, or the top portion of your personal property or real estate tax bill.

The decal is not transferable and may be revoked if used in violation of the Solid Waste system regulations, including the requirement that the decal not be given to or shared with non-County residents, or commercial users. The decal does not relieve you of any fees that may be applicable. County staff reserves the right to ask for other identification.

There is no charge for this decal and the decal does not expire. No more than 2 (two) decals per address will be issued.

The decal must be permanently affixed to the inside of the vehicle windshield on the driver's side, within 1" from the left edge and 2-3 inches above the State Vehicle Inspection sticker (see illustration above). Loose or taped decals will not be accepted.


Note from Taxpayer Services for PWC Residents serving in the Military - County Ordinances require all persons to register their vehicles locally, even vehicles with out-of-state tags. If a person is in the military and lives in the County, he or she needs to provide a copy of the vehicle registration (to establish ownership) and an LES (Leave and Earnings Statement). The LES establishes that the person is a member of one of the armed services and shows the state of residence. If the vehicle is owned by someone on active-duty (a spouse may co-own the vehicle), it is exempt from fees. Active duty military personnel may keep the out-of-state registration/tags, but does have to register the vehicle with Taxpayer Services since County ordinance requires it, and landfill stickers can only be issued to vehicles registered locally.
