### Accept Rapid Rehousing Benchmarks- accepted by consensus

• The National Alliance to End Homelessness has given benchmarks to reduce make homelessness rare, brief and non-reoccurring. The performance measures will look at the length participants spend homeless, permanent housing success rates and returns to homelessness. Prince William County DSS is working with HMIS to retrieve this data and set specific and measurable goals for the county.

#### **New Business:**

• Committee reports were accepted, Jacob Mosser 1<sup>st</sup>, Randi Knights 2<sup>nd</sup>. Committee Reports were accepted by consensus.

#### Governance

• The Governance committee made recommendation to the Board of County Supervisors to appoint Brandi Day to represent the Continuum of Care on the Housing board – approved Randi Knights 1<sup>st</sup>, Rose Powers 2<sup>nd</sup>. Recommendation was accepted by consensus.

## VHSP Funding Recommendation for FY 18 renewals:

• All applying agencies were funded for renewals. Operation Renewed Hope Foundation (ORHF) reduced its funding level by \$8,988. The funds were reallocated evenly to the remaining four applying organizations, giving an increase of \$2,247 to Action in Community Through Service, BARN, Northern Virginia Family Services (NVFS) and Prince William County Department of Social Services. The Program and Analysis Ranking (PAR) committee will give feedback and regulations for future grant competitions and applications. -Lynn Fritts 1<sup>st</sup>, Karen DeVito 2<sup>nd</sup>. Funding recommendations approved.

### Reallocation request for ORHF FY17 funds.

• ORHF requested to reduce its FY 17 budget by \$8,000.00. Prince William County Department of Social Services recommended that fund be reallocated to NVFS to serve clients at the SERVE and Hilda Barg Shelters. -Reallocation of funds accepted by consensus.

## Special Guests

• Nichelle Carver and Kendall Cloeter from the Virginia Department of Housing and Community Development presented information on the state goals and performance measures that will take place in the upcoming year. They discussed that every CoC should be in the process of adopting and implementing the Rapid Re-Housing Benchmarks and fully adhere to them by July 1, 2017. Coordinated Assessment must be implemented by January 23, 2018. Additionally, they recommended local service providers attend an Emergency Shelter training from the National Alliance to End Homelessness on May 4, 2017 at George Mason University.

#### Announcements:

- There are no more transportation funds remaining for the year. All cab service funding ended on April 11, 2017 at 5pm. Prince William Department of Social Services will inform all service providers when more funding is available.
- The Bill Mehr Drop-In Center meet and greet event was very successful, with 29 vendors and 15 clients. The center will open for clients on April 17, 2017.
- Minerva Labrador is leaving Northern Virginia Family Services as the Hilda Barg Shelter Director. Andrea Sullivan will be the new director with a tentative start date of May 1, 2017.
- ACTS received funding from the Housing Trust Fund affordable housing production program.
