

New Business

VHSP Second Round of Funding Updates

- Tony Turnage provided an update on the second round of COVID -19 allocated funding from the state. NVFS has received 450k of state funding to operate the Rent Mortgage Relief Program (RMRP) that started July 1, 2020.
- Kathy Bridgeman gave an overview of RMRP:
 - o PWC- 93 referrals with a total of 275 referrals across all three jurisdictions and 70% of the referrals are below 50% AMI.
 - o Referrals are made through via Coordinated Entry System.
 - A total of \$450K is specific to the PWA and includes the cities of Manassas and Manassas Park.
 - o The DHCD website has tools to determine eligibility to apply for the funding.
 - NVFS will help with language barriers and lack of access to computer or internet.
 Applicants are required to provide a statement that their conditions are directly related to COVID.

- o Citizenship or SSN is not required for funding.
- Joan Duckett provided an update on the housing applications they have received.
 - o 421 applications received
 - o 4 applications denied because the loss of income was not COVID-19 related.

Identification of Volunteers to serve on the Nominating Committee

- Nominating Committee: Allan Jones, Michele Gehr, Courtney Tierney and Maria Wells to nominate representative for the Governance. Chair Johnson appointed Tierney as his designee to lead the group.
- Motion to approve nominating committee. Motion unanimously approved. 1) Karen DeVito 2) Roberta McEachern with three abstentions: Allan Jones, Maria Wells and Michele Gehr.

Procedural Change: Representation of Manassas & Manassas Park (Governance Committee)

 Manassas City and Manassas Park will serve as alternates to each other on the Governance Committee. Recommended wording will be provided at the next CoC meeting to update the language in the bylaws to reflect this.

Lead Agency Updates

- Tony Turnage presented the DSS Lead Agency Update.
 - o Committee updates
 - Crystal Pitt of NVFS will represent the Service Continuum Committee on the Governance committee, Allan Jones will represent the DANA committee, and Tony Turnage will represent the PAR committee.
 - o The Overnight Shelter and Drop-In Center
 - ➤ The overnight shelter has moved back to Ferlazzo on June 22, 2020. The Drop-in Center will remain closed at this time. Drop-in Center staff has been assigned to the Ferlazzo building to assist with daily services.
 - Motel Program
 - Motel continues to operate with 38 people enrolled in the program and doing well.
 - ➤ The only clients in the program are persons with underlying health conditions; no clients at this time who are COVID positive or COVID exposed.
 - o Permanent Supportive Housing (PSH)
 - The CoC will be focus on moving clients from motel program, shelters, and the encampments into permanent supportive housing, rapid re-housing, or any housing options available.
 - ➤ Jeanine Gravette will conduct training to review the referral application process for RRH and PSH on Friday, June 17, 11:00 2:00 pm or 11:00 3:00 pm. The process has been simplified.
 - The OHCD has a new COVID-19 Emergency Housing Assistance Program for eligible households who have experienced financial hardship due to COVID-19. Applications are available on the PWC website.

Coordinated Entry System Policies and Procedures Manual (CES)

➤ CES policies and procedures have been approved by Governance. CES policies has been sent to the CoC and we will vote on this at the next meeting. Biggest high-level change is the residency policy to serve PWA residents as a priority.

Agency Spotlight:


Jason Shriner, PFLAG Representative and Transition Assistance Program (TAP) Virginia.

- Jason Shriner introduced Ms. De Sube of the Transition Assistance Program (TAP) Virginia to the committee.
- Ms. Sube gave an overview of the TAP program and the statistics of transgender homeless individuals:
 - o Sex work becomes more lucrative though not desirable when no work is available or when there aren't many jobs.
 - The biggest barriers for Transgenders to locate jobs are transphobia, homophobia and homeless phobia.
 - o There are not any Trans Affirming Shelters located in the Northern Virginia area.

- Nancy Espinal Department of Veteran Affairs: gave an update on meeting with a biweekly basis review the veteran list to obtain appropriate referrals for the HUD-VASH program and determine any other services available.
- Lakia Graham Virginia Employment Commission is scheduled to open back up by virtual appointment only for job services.
- Lewis Arnettee Easterseals: the updated grant department of labor grant started July 1st to continue to send veterans to online schools and training programs. They are purchasing computers to provide to veterans, so they are able to attend classes.

Update on Homeless Crisis Response Plan Motel Program

- Jeanine Gravette gave a brief reviewed of the PWA CoC changes to Coordinated Entry changes for Permanent Housing Solutions due as part of the CoC's COVID-19 response (*attachment*).
 - Motion was made to accept the changes to Coordinated Entry changes as stated in the document. 1) Maria Wells 2) Crystal Pitt
 - o Motion unanimously approved.

Shelter updates

- The following providers gave a brief update on the shelter program.
 - o Action in Community Through Service (ACTS)
 - > ACTS opened up the East Safe house and it is currently full.
 - o Northern Virginia Family Service (NVFS)
 - NVFS had great successful moves out since the pandemic began and were able to place large number of clients into homes and few clients were able to resolve their own homeless crisis. The shelter is back to full capacity.
 - Homeless Services Division Hilda Barg
 - > Tonya Golden is the new Director at the Hilda Barg Homeless Shelter and there are no other updates.
 - o Homeless Services Motel Programs
 - ➤ There are currently 37 clients' in the motel program, and it is going well. Homeless services is working on processing of all applications for PSH and Rapid Re-housing.
 - o Streetlight Community Outreach Ministries Overnight Shelter
 - The overnight shelter has relocated back to Ferlazzo building and it is going well.
 - > Streetlight is working with Homeless Services to refer clients in the motel program, unsheltered or in shelter to Permanent Supportive Housing, Rapid Rehousing or any available housing options to avoid overflow as quickly as possible.

Coordinated Entry System Policies and Procedures Manual (CES Manual)

• The Coordinated Entry System Policies and Procedures Manual is currently being reviewed by the Governance Committee.

- Jeanine Gravette gave a brief overview of the high level of changes. The following changes were addressed:

Welcome and Introductions

• Elijah Johnson introduced Crystal Pitt, the Director of Northern Virginia Family Service to the committee. Crystal Pitt was appointed to represent the Service Continuum on the Governance committee.

Meeting called to order: 1:04 p.m.

Approval of June 11, 2020, CoC Meeting Minutes.

- **Approval of CoC Minutes** -July 9, 2020, CoC Minutes approved: 1) Allan Jones 2) Randi Knights
- Approval of Committee Summaries All committee summaries were approved as amended.
 - 1) Allan Jones 2) Tony Turnage
 - O Data and Needs Analysis (DANA) Committee
 - Tony Turnage reviewed the DANA summary.
 - o Allan Jones suggested to send out a survey to the CoC committee on how the DANA committee can better serve the CoC community.
 - o Service Continuum Committee

Tony Turnage and Crystal Pitt reviewed the Service Continuum summary. A motion was made to amend the proposed PWA Coordinated Entry under the prioritization populations to include the sentence that reads the following: "If no eligible clients meet the requirements in the categories, the CoC will convert back to the original Prioritization guidelines."

Motion was approved unanimously. 1)Tony Turnage 2) Crystal Pitt

DSS Lead Agency Update:

- Tony Turnage presented the DSS Lead Agency Update.
 - o Tony Turnage discussed the two housing programs in the Continuum of Care with the committee.
 - Rapid Re-housing program with Northern Virginia Family Service (NVFS), which was the former BARN money. The program is to focus on training and education components for individuals participating in the program. The goal is to focus on low need households to increase their income.
 - The Permanent Supportive Housing program (PSH) will be operated by Pathway Homes. The PSH programs will start on October 1, 2020. The referral process is being made and there is a training schedule for July 24, 2020, to simplify the referral process with PSH and Rapid Re-housing via WebEx.
 - o Emergency Food Shelter Program (EFSP) Community Applications
 - The EFSP Board members are in the process of finalizing the reviews of the applications to award applicants.
 - The EFSP Board tried the new assessment tools and it is working well. After the finalization of the applications and appeal process, Oliver Reid will provide updates at the next Governance committee.
 - o COVID-19 Programs
 - The hotel program served 49 totals person, five persons in families consisting of two households and 44 single individuals for the month of June.
 - The Overnight Shelter served 81 individuals for the month of June.
 - Agency Spotlight
 - Tony Turnage recommended The Project ID & Spread the Vote Alexandria/ Springfield be the Agency Spotlight at the next CoC meeting, August 13, 2020.
 - Courtney Tierney suggested that the committee bring an Election Officer to speak in the September CoC meeting as the Agency Spotlight. Courtney will reach out to the Election Officer.
 - Prevention Funding/Rent and Mortgage Relief Program Operated by NVFS
 - Northern Virginia Family Service has created a portal that allows applicants to complete their application. The portal has created a couple of challenges:
 - Landlords needing to talk with NVFS staff and a request for FAQ page on the website for landlords; and
 - o The incorrect phone number was listed by DHCD which created some frustration for persons attempting to apply for the funding.
 - The Homeless Services Division will reach out to Kathy Bridgeman to have a discussion on the challenges and how to best to ease the process of the application and best serve the community.
 - o PWC Office of Housing & Community Development (OHCD)
 - OHCD is still processing the COVID-19 Emergency Housing Assistance Program and the application can be processed online.
 - The Office of Housing has received over 600 applications, so far 30 have been approved and 20 have been denied. Some issues with the applications are missing documentation that is delaying the application process.

Voting on an At Large Member

- Courtney Tierney provided updates on the nominating committee. The updates are as follows:
 - o The nominating committee will meet next Tuesday, July 28, 2020, and will be ready to move forward with electing the nominee at the next CoC meeting scheduled for August 13, 2020; and
 - o There are 5 interested candidates.
