- Nichele Carver and Cheryl Plourde:
 - o Provided information about the VHSP (Virginia Housing Solutions Program grant). They stated that as the agency that oversees the Commonwealth's Continuums of Care, they appreciated all the work that has been done to restructure the PWC CoC. They reiterated we must streamline services as a community.
 - The CoC's policies and procedures should supersede an individual agency's programs 'policies and
 procedures. We are expected to have service consistency throughout the PWA. There is a new Homeless
 Outcomes Community Report that is essential for future funding.
 - o All data, beyond state and federal funding, should be reported to the CoC.
 - HUD just released Rapid Re-housing Performance Measures and Standards.
