- Nichele Carver from Virginia DHCD provided updates from the state office:
 - ✓ Cheryl Plourde has left the Department. Ms. Carver is the PWC contact in Ms. Plourde's absence.
 - \checkmark She noted a positive "huge difference" in the CoC over the last nine years.
 - ✓ She stated that the aforementioned \$100,000 request needs to address the 42% in spending which is on track and answer why the new funds are needed.
 - ✓ All CoCs must accept the Rapid Re-Housing Benchmark standards by June 30, 2017.

- ✓ When remittances are late, it makes it look like funds are not being spent and confuses the case for the need for more funding.
- \checkmark Recommends that remittance are submitted monthly to DHCD.
