Additional Funding

- Courtney Tierney announced the Commonwealth's Virginia Homeless Solutions Program funds during COVICD-19. The request was submitted to the state as follows:
 - o Prince William County DSS-\$189,000
 - o Streetlight-\$3,000
 - o NVFS-\$3,000
 - o ACTS-\$3,000

Motion was made to approve the additional funding amounts listed above. Motion was approved 1) Karen DeVito 2) Lynn Fritts with four abstentions: 1) PWC 2) Streetlight 3) ACTS 4) NVFS

DHCD Application

- Tony Turnage provided updates on the DHCD Application and COVID-19 Funding with the committee and the following were addressed:
 - o Application was successfully submitted in the amount of \$844,287 for the following:
 - CoC Planning
 - HMIS
 - RRH (includes a new project focused on training)
 - Prevention Services
 - Housing Location Services
 - o Current Funding is \$809K. Due to COVID-19, PWC has been provided with an additional \$198K to provide services to the homeless (Governor Northam has provided \$2.5 million for the entire state).

Lead Agency Updates

- Tony Turnage presented the DSS Lead Agency Update on the following matters to the CoC committee:
 - o 2019 HUD Application for July 1, 2020, thru June 30, 2021 was awarded.
 - o CoC was awarded additional \$277,000 for PSH programs that will house 12 chronically homeless persons. The total funding awarded is \$994,546.
 - 2020 HUD Application- The Council of Governments has sent a letter to HUD headquarters requesting that HUD streamline the 2020 Application Process due to COVID-19.
 - O The Homeless Services Division is hosting a meeting with homeless shelters and rapid rehousing providers on Mondays and Fridays at 11:30 a.m. regarding issues to COVID-19 and other homeless issues. If anyone wishes to join the meeting, please contact Tony Turnage or Oliver Reid.
 - o Elijah Johnson suggested that the Homeless Services Division send out an invitation to the providers to see if they would like to join the meeting.

DSS Lead Agency Update:

 Tony Turnage discussed the opening of the COVID-19 Homeless Crisis Response Plan using m/hotel rooms for persons experiencing homelessness. The following areas were addressed:

- ➤ The number of current clients at the hotel (14) is expected to increase over the next few weeks.
- > Staffing assignment and recruitment.
- ➤ Program can serve up to 52 households. 8 rooms allocated to clients exposed to COVID-19.
- ➤ Food/Meal services are provided.
- ACTS have informed DSS that they cannot continue to operate the PSH program which opened in July 2019.
 - ➤ ACTS would like to convert their current PSH project back into a program for domestic violence clients.
 - ➤ Oliver and Tony are working on a timetable to develop a plan on next step housing for existing clients.
- o DHCD is having a meeting with Northern Virginia CoC's to discuss a second round of funding scheduled for Friday, April 24, 2020.

Information from the Chair

- o Elijah Johnson discussed the overview of the availability and distributions of funds with the Committee:
 - Emergency Solutions Grant Care Act (ESG) \$790K
 - Community Development Block Grant CARE Act (CDBG) \$1.5 Million
 - Prevention Funds \$500K
- O The Human Services Alliance of Greater Prince William has partnered with Prince William County Government and the cities of Manassas and Manassas Park to collect donations for the Prince William Area Disaster Fund. \$10K has been collected so far.
